NOTIFICATION

G.S.R. . . . . In exercise of the powers conferred by section 87 of the Punjab Re-organisation Act, 1966 (31 of 1966), the Central Government hereby extends to the Union territory of Chandigarh, the Punjab Motor Spirit (Taxation of Sales) Second Amendment Act, 1974 (Punjab Act 16 of 1974), as in force in the State of Punjab at the date of this notification, subject to the following modifications, namely :-

MODIFICATIONS

1. In section 2, for the words, brackets and figures "the Punjab Motor Spirit (Taxation of Sales) Act, 1939", the words, brackets and figures "the Punjab Motor Spirit (Taxation of Sales) Act, 1939, as in force in the Union territory of Chandigarh" shall be substituted.
2. Section 3 shall be omitted.

ANNEXURE

THE PUNJAB MOTOR SPIRIT (TAXATION OF SALES) SECOND AMENDMENT ACT, 1974 (PUNJAB ACT 16 OF 1974) AS EXTENDED TO THE UNION TERRITORY OF CHANDIGARH.

An Act to amend the Punjab Motor Spirit (Taxation of Sales) Act, 1939.

Be it enacted by the Legislature of the State of Punjab in the Twenty-fifth Year of the Republic of India as follows :-

- Short title.      1. This Act may be called the Punjab Motor Spirit (Taxation of Sales) Second Amendment Act, 1974.

2. In the Punjab Motor Spirit (Taxation of Sales) Act, 1939, as in force in the Union territory of Chandigarh, in section 3, in sub-section (1), -

- (a) in clause (a), for the words "seven paise" the words "ten paise" shall be substituted; and
- (b) in clause (b), for the words "nine paise" the words "fifteen paise" shall be substituted.

3. Section 3 shall be omitted.
