Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of July ,2021.

Virtual interaction of Hon' ble Prime Minister, Home Minister and Minister of State (N), MHA with IPS probationers of 72 RR was conducted successfully on 31.07.2021.

- 2. A meeting was chaired by the Hon'ble Home Minister with the Chief Ministers, Chief Secretaries and DsGP of NE States on 24.07.2021 at Shillong (Meghalaya) to review the various issues in respect of the NE States. The meeting was also attended by Minister of DoNER and Tourism, Minister of Science and Technology 86 Earth Sciences, Union Home Secretary and other senior officers of MHA.
- 3. Hon'ble Home Minister chaired a meeting of the High Level Committee and approved additional financial assistance to Karnataka and Maharashtra for floods of 2020 and Rajastian for drought (kharif of 2020). Department of Expenditure was advised to release Rs 629.03 crore to Karnataka and Rs 701 crore to Maharashtra.
- 4. Union Home Secretary Held the following VC meetings to review the Covid-19 situation:
 - (i) On 7th July, 2021 reviewed the COVID-19 situation in Union Territories (UTs) and North Eastern States.
 - (ii) On 10th July, 2021, reviewed the steps taken by State Government of Rajasthan, Kerala, Goa, Tamil Nadu, West Bengal, Uttarakhand and Himachal Pradesh for checking the spread of Covid-19 in hill stations and tourist locations.
 - (iii) Three meetings of the Empowered Group 10, were held through VC on 9th July, 16th July and 23rd July 2021 to discuss the issues related to containment strategies, logistics and supply chain management.
- 5. On 14.07.2021, a DO was addressed to the Chief Secretaries and Administrators of States/UTs to issue strict directions to the district and all other local authorities' concerred, to regulate the crowded places and take necessary measures for management of COVID- 19.
- 6. On 28.07.2021, order issued under the Disaster Management Act, 2005, to ensure compliance to the containment measures for COVID-19 management, as conveyed vide MoHFW advisory dated 28.06.2021 until 31.08.2021. Thereafter DO letter issued to Chief Secretaries and Administrators of States/UTs to ensure strict compliance and necessary measures for management of COVID-19.

- 7. On 23.07.2021 an MOU has been signed among MHA & NICSI, NIC, NRSC regarding execution/implementation of Integrated Control Room for Emergency Response (ICR-ER).
- 8. On 06.07.2021, Union Home Secretary held a meeting with Chief Secretary Assam to discuss implementation of Bodo Agreement (2020).
- 9. On 09.07.2021 and again on 28.7.202, Union Home Secretary reviewed the inter- state boundary issues along Assam-Mizoram border with the Chief Secretaries/DsGP of Assam and Mizoram at New Delhi
- 10. Singapore High Commissioner met Union Home Secretary on 20th July, 2021 to discuss bilateral issues of mutual interest.
- 11. Total 86 Coys of CAPFs as direct induction have been ordered for deployment in the States of Gujarat, Uttar Pradesh, Delhi, Meghalaya, Bihar and Telangana for law and order duties for a specific deployment period.
- 12. 2000 ex-Army personnel on contractual basis was appointed. Out of 2000, 1265 candidates have been selected and they have been directed to report to the concerned unit by 01.08.2021.
- 13. On 14th July, 2021 sanction was conveyed for Rs. 52,96,517/- under Swacchhta Action Plan for construction of Sewage Treatment Plant (STP) cum Effluent Treatment Plan (ETP) along with installation of new Online Monitoring System (OLMS) and get the same connected with the online servers of Delhi Pollution Control Committee (DPCC) as well as Central Pollution Control Board (CPCB).
- 14. On 26.07.2021 meeting of EFC was held for inclusion/continuation of IR Bn. Scheme in the Umbrella Scheme on Modernization of Police Force of financial implication of Rs. 350.00 Crore.
- 15. On 27.07.2021, meeting of EFC was held for continuation of Umbrella Schemes of Police Infrastructure Building Project of CAPFs, CPOs and Delhi Police beyond 31.03.2021 and Central Sector Scheme viz. BSF Air Wing, Aircraft, Riverboat & Helibase with an estimated outlay of Rs. 21087.11 crore and Rs. 732.05 crore respectively.
- 16. Modernization Plan- IV for Central Armed Police Forces has been appraised by EFC on 27.07.2021.
- 17. On 1st July, 2021, sanction for prosecution for filing the charge sheet against 11 accused persons was accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967 and seized Fake Indian Currency Notes (FICN) having face value of Rs. 10,36,000/-.

- 18. On 07.07.2021, Additional Secretary (NE), chaired a meeting to review the implementation of Bru Agreement (2020).
- 19. On 25.07.2021, Union Home Secretary held a meeting with DG, Narcotics Control Bureau and DsGP of NE States at Shillong (Meghalaya) on drug trafficking in NER.
- 20. During the month of July 2021, more than 3700 kg of Narcotic substances have been seized and 69 persons were arrested for their involvement in drug trafficking during the month under report.
- 21. During the Month of July, 2021 amount of Rs.3.84 crore has been released to the State Government Arunachal Pradesh under Border Area Development Programme (BADP).
- 22. A VC meeting of Empowered Committee was held on 15th July, 2021 under AS (LWE) to review the progress of developmental works in respect of financial inclusion in LWE affected districts with the representatives of Department of Expenditure, Department of Post & Department of Financial Services.
- 23, An Advisory has been issued to State Government /CAPFs to sensitize them to counter the LWE activities in the LWE affected areas.
