NOTIFICATION

New Delhi, the 11th June, 2009

G.S.R. 403(E).— In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Police Service) Rules, 2003, namely :-

1. (1) These rules may be called the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Police Service) Amendment Rules, 2009.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Police Service) Rules, 2003 (hereinafter referred to as the said rules), in rule 4, in sub-rule (1), in the second proviso, for the word and figures "Rs.12000-16,500", the word and figures "Rs.15,600-39,100/- plus Grade Pay Rs.7600" shall be substituted.

3. For Schedule I to the said rules, the following Schedule shall be substituted, namely:-
