G.S.R. 717(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules to amend the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Civil Service) Rules, 2003, namely: -

- (1) These rules may be called the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Civil Service) Amendment Rules, 2009.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the National Capital Territory of Delhi, Andaman and Nicobar Islands, Lakshadweep, Daman and Diu and Dadra and Nagar Haveli (Civil Service) Rules, 2003 (hereinafter referred as the said Rules) in Rule 4, in sub rule (1), in the second proviso for the words and figures Rs.12,000-16,500/- the words and figures "Rs.15,600-39,100/- with Grade Pay of Rs.7,600 in the Pay Band-3", shall be substituted.
- 3. In the said Act, for Schedule-I, the following Schedule shall be substituted, namely: -
