# Guidelines (Revised) for allocation of funds to CAPFs from CAP Budget Head of Jammu & Kashmir

#### 1. Objectives:

To win over the heart and mind of the people and for mainstreaming of youth of Jammu & Kashmir.

# Organizations to whom Funds can be allocated:

Central Armed Police Forces, Jammu & Kashmir Police and reputed Non Govt. organizations i.e. SEWA etc. The funds however be released to such organizations through CAPF. The proposal relating to activities in the State of J&K and Stake Holders of J&K would be consider in the CAP.

## 3. Authority to approve activities for which funds to be utilized:

Home Secretary, Ministry of Home Affairs

### 4. Activities for which funds shall be allocated:

- (i) Organizing Medical Camps, including dental, veterinary and maternity camps, particularly in border districts, remote areas which are not within the easy reach of Government health centers, and for weaker sections and vulnerable population; distribution of medicines in such camps. However, no medical equipment to be provided to the patients
- (ii) Human Resources Development to include imparting of vocational training, conduct of education excursions by the students to places of national interest and the like, organized career counseling, training and coaching etc
- (iii) Sport Facility
- (iv) Supporting women for setting up projects on issues relating to National Integration, Democracy, Democratizing the local level institutions, Empowering women, issues relating to social concerns, improvement of livestock, beekeeping, fisheries, agricultural techniques, orchards, forestry,

carpet/ handloom weaving, hosiery, development of non-conventional/ renewable energy, handicrafts, cottage industries, cutting/ tailoring, food processing, etc

- (v) Providing assistance during natural calamities,
- (vi) Distribution of transistors

#### Note:

The above list is only indicative and not exhaustive. The changes may be made in the list depending upon the requirements and items likely to strengthen CBMs

#### Methodology for allocation of Funds:

The Central Armed Police Forces (CAPFs) and / or the reputed organizations of NGOs working in the field of confidence for mainstreaming the vulnerable sections of the society including the youths would submit a detailed plan of activities proposed to be undertaken by them during a period, giving a break-up of physical and financial targets on a yearly basis in the beginning of the calendar year preferably January.

The following Committee shall examine and submit its recommendations for the approval of Union Home Secretary:-

- (i) Joint Secretary (Kashmir) Chairman
- (ii) DGPs of concerned CAPFs or an officer not below the rank of IG authorized by him.
- (iii) DS/Director (K-I Division)
- (iv) A representative of DGP, J&K.

The funds will be released in installments depending upon the progress of work. MHA will inspect and supervise these activities from time to time. The CAPFs/JKP shall submit the Utilization Certificates as per the format, time frame provided in the GFR.
