Subject: Amendment to Delegation of Financial Powers to Director Generals of CAPFs for procurement of Arms and Ammunition.

In partial modification of this Ministry's Order No.11012/2/2009-Fin-I/Prov.I dated 16.10.2014 and No. 11012/02/2009-Fin-I/Prov.I dated 02.01.2018, it has been decided to enhance the financial powers delegated to DGs of CAPFs for procurement of Arms and Ammunition for the CFY (2022 -23) as follows:
