Subject: Mechanism for induction of DRDO developed products in CAPFs and placement of orders by user CAPFs with Development-cum-Production-Partner (DcPP)/Production Agency (PA).

Reference is invited to the minutes of Second Apex Council meeting held on 24.02.2021 under the co-chairmanship of HS and Chairman, DRDO and MHA's OM No. IV-24011/24/2019/MHA-Prov.I dated 15.07.2020 on the subject mentioned above.

2. As proposed by DRDO and discussed during the second Apex Council meeting held on 24.02.2021, the competent authority in this Ministry has approved to add following provisions to para 2B (ii) of MHA's OM No. IV-24011/24/2019/MHA-Prov.I dated 15.07.2020 :

(i) In case of a single ToT holder for DRDO developed systems, the same may not be treated as a single vendor case for procurement subject to the condition that DRDO shall inform the name of the development cum production partner/production agency/ ToT holder of the DRDO developed system.

(ii) If Indian Armed Forces have procured any DRDO developed products then CAPFs may also place the supply order for the same on the same vendor. Ministry of Defence/Army shall confirm the supply order placed for the DRDO developed system along with its terms & conditions.

(iii) The delegated financial power of DsG and other lower functionaries of CAPFs in case of open/limited tender enquiry would be applicable in both the above mentioned situations.

(iv) The provisions of GFR would need to be followed in consultation with the IFA of the concerned CAPF.

(v) DRDO shall inform the name(s) of Development cum Production Partners [DcPP(s)]/Production Agency/ToT holder(s) of the DRDO developed systems to CAPFs.
