Sanction of the competent authority is hereby accorded to the delegation of financial powers to the level of Joint Secretary, MHA and RGI (irrespective of rank of AS or JS) on the following items:-

(This does not affect the powers already delegated to the authorities below the level of JS in MHA and also in attached/subordinate offices of MHA.)

- The above mentioned delegated financial powers shall be exercised by the respective officers subject to strict observance of the following conditions:-
 - (i) The authorities to whom these powers are being delegated shall not further delegate these powers.
 - (ii) All codal formalities should be followed as per the provisions laid down in GFR, DFPR, MoF Manual for 'Procurement of Goods' 2017 and MoF Manual for 'Consultancy & Other Services' 2017, CPWD Code/Works Manual, CVC guidelines, Economy instructions and other instructions issued by the MoF, MoUD and MHA from time to time.
 - (iii) Budgetary provisions should exist in the financial year concerned.
 - (iv) These powers would be exercised in consultation with the Integrated Finance Division (IFD), MHA except Point 16 of Para 1 above (IFD's OM No. 6/MHA/IFd-2016 dated 31.05.2016 may refer).
 - (v) In case where the award of contract or purchase or consultancy is inseparably linked with the project or scheme and forms a part of the proposals for SFC or EFC or Cabinet, the same will be processed as per the financial limits laid down for sanction of such schemes or projects by the competent Authority....... Further, a limited or open tender which

results in only one effective offer shall also be treated as a single tender contract. (Refer DFPR Rule 21(b))

- 3. These delegated powers will be effective from the date of issue of the orders.
- 4. This issues with the concurrence of Integrated Finance Division of Ministry of Home Affairs vide their CF.No. 3372898/AS&FA(H) dated 01.09.2017 and with the approval of the Home Secretary.
