Subject: Delegation of financial provem for procurement of operational vehicles for replacement of condemned vehicles to the DGs of Central I on Military Forces.

In securidance with the instructions issued by the Ministry of France, Department of Expenditure vide his ID Note No. 7(1) E. Coordination dated 1.11.08 and 16.12.03 and in exercise of power under Rule 13(2) of Delegation of Financial Power Rules. 1973, the powers for purchase of operational vehicles for replacement of cond-mand vehicles for security related organizations in MHA have been delegated to the United Home Secretary in containing with the Financial Advisor of Ministry of Home Affair.

- 2. In consultation with the Ministry of Finance. Department of Expenditure vide letter No. 1669/SF2010 dated 22.3.10, the DGs of Central Para Military F were are delegated the powers for procurement of vehicles in replacement of condemned vehicles subject to the following:-
  - (i) The procurement of vehicle should be against authorised which

(ii) The vehicle should have been andenned.

- (iii) The procurement will be only against the replacement of the conduntated vehicle.
- (iv) The vehicle will be procured only from the list of numbersed vehicles to the CPMFs.
- (v) The vehicle will be procured from DGS&D Rate Contract.
- (vi) Strictly like to like replacement should be done.
- (vii) A besic stock! stay be replaced by a basic stock!.
- (viii) The session of deployment should be the sense as that where the vehicle is being condemned.
- (ix) FAs will ensure that there is no deviation from these guidelines, and for any deviation FAs of CPMFs will be held responsible.
- (x) A quarterly report will be submitted to AS&FA(Home) indicating the vehicles proposed.
