Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of May, 2022.

The National Executive Committee (NEC) meeting was held under the chairmanship of union Home Secretary on 10.05.2022, to review preparedness for Severe Cyclonic Storm "ASANI" over west central Bay of Bengal.

- 2. Annual Conference of Relief Commissioners/Secretaries, Department of Disaster Management of States/UTs to review the status of preparedness for South-West Monsoon, 2022 was held on 18th & 19th at Vigyan Bhawan, New Delhi. The conference was inaugurated by Union Home Secretary.
- 3. On 05.05.2022, Union Home Secretary chaired a meeting with the Secretary, MoRD to review the progress of construction of Roads/Bridges under Road Construction Project for LWE affected areas.
- 4. On 11.05.2022, Union Home Secretary reviewed the availability of latest technology i.e Multi Mode Passive Detection System (MMPDS) in the field of Truck Scanner with Department of Atomic Energy, Central Board of Indirect Taxes & Customs, Land Ports Authority of India and Central Reserve Police Force.
- 5. On 23.05.2022, a meeting was held under the Chairmanship of Home Secretary to discuss the apportionment of pension liabilities between Bihar and Jharkhand, with the Chief Secretaries and Principal Accountant Generals of both the states.
- 6. Further, on 31.05.2022, Union Home Secretary hold a meeting to discuss the issue of allocation of adequate funds to NE States under Compensatory Afforestation Fund Management and Planning Authority (CAMPA)/ other schemes of MoEF & CC to improve forest cover in North Eastern Region (NER).
- 7. Further, on. 12.05.2022, Secretary (Coord), MHA hold a meeting with Ministry of Road. Transport & Highways to review the progress in issues related to Central Motor Vehicles Registration (CMVR) being faced by CAPFs during registration/procurement of vehicles.
- 8. A meeting was held on 24.05.2022 under the chairmanship of DG (Awards) with the representatives of State of Gujarat and UT Administration of Dadra & Nagar Haveli and Daman & Diu (DNH & DD) to discuss the issues of Transfer of land to DNH & DD in lieu of land given to Gujarat at Simbor in 1989 & Transfer of 4 villages (Meghval, Nagar, Raymal & Madhuban) from the State of Gujarat to Dadra & Nagar Haveli and Daman & Diu.
- 9. On 26.05.2022, a meeting of Monitoring Committee was held under Additional Secretary (North East), MHA to monitor and redress issues relating to racial discrimination faced by the people of North East,

- 10. A four-member Indian Delegation, led by Mr. Kamal Kishore, Member and Secretary (1/C), NDMA attended the 7th session of the Global Platform on Disaster Risk Reduction, in Bali, Indonesia from 23-28 May 2022. Dr.P.K.Mishra, Principal Secretary to Hon'ble Prime Minister delivered a key note address, through VC, during the inaugural, plenary session of the World Reconstruction Forum.
- 11. A meeting under Additional Secretary (DM) was held on 17.05.22 to review the preparedness measures to deal effectively with the crisis situation in Ropeway projects.
- 12. On 13.05.2022, Additional Secretary (LWE) held a meeting with the Nodal Officers from Bihar, Chhattisgarh and CRPF regarding review of FOBs/Camps under Assistance to Central Agencies for LWE Management (ACALWEM) Scheme.
- 13. On 18.05.2022, AS(LWE) held a meeting with the officers of MoRD regarding implementation of Roshni/Deen Dayal Upadhyay Grameen. Kasuhalya Yojana. (DDUGKY) in LWE Affected areas.
- 14. One Advisory was issued to State Governments/CAPFs to sensitize them to counter the LWE activities in the LWE affected areas.
- 15. EFC meeting to appraise MHA's proposal regarding the Vibrant Village Programme was held on 20.05.2022.
- 16. 2nd Negotiation Meeting was held on 9-10 May, 2022 in New Delhi with Italy to finalize the MLAT in Criminal Matters. JS(CIC) led the Indian delegation, while the Italian delegation was led by Mr. Stefano Opilio, Director General for International Affairs and International Judiciary Cooperation, Italian Ministry of Justice. Agreed Minutes have been signed between the Heads of Delegation on 10.05.2022.
- 17. An exercise was undertaken in CAPFs to rationalize the Forms/Registers used in CAPFs. 1178 Forms/Registers have been reduced to 451 i.e. 118 common and 333 Force specific. Some of these forms have also been digitized and efforts are in hand to digitize more number of forms/registers.
- 18. 212 posts were sanctioned for augmentation of CISF personnel at Numaligarh (NRL) Assam.
- 19. Total 47 Goys of CAPFs (BSF-07, CRPF-07, RAF-22, ITBP-07 & SSB-04) as direct induction have been ordered for deployment in various States of Punjab, Chandigarh, Telangana & Uttar Pradesh for law and order duties for a specific deployment period. Further, total 09 Coys of CAPFs (BSF-02, CRPF-03, SSB-02 & CISF-02) as direct induction have been ordered to deploy in Kerala, Odisha Uttaralchand for Bye-Election related duties.
- 20. Deployment period of 14 Coys of CAPFs (BSF-03, CRPF-06, SSB-02 & CISF-03) have been extended during May, 2022 in various States of Delhi, Haryana & Ladakh) for law and order duties.

- 21. The Registration (Tamil Nadu Amendment) Bill, 2021 and the Prohibition of Child Marriage (Haryana Amendment) Bill, 2020 have been assented to by the Hon'ble President of India on 07.05.2022 and 13.05.2022 respectively.
- 22. The Code of Criminal Procedure (Jharkhand Amendment) Bill, 2020 and The Code of Criminal Procedure (Karnataka Amendment) Bill, 2021 have been assented to by the Hon'ble President of India on 24.05.2022.
- 23. Instructions for promulgation of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Tripura Amendment) Ordinance, 2020" have been conveyed to the State Government on 18.05.2022.
- 24. During the month, more than 3725 kg of narcotic substance, 2710 of Tramadol tablets and 39479 bottles of Codeine based cough syrup were seized and 44 persons were arrested for their involvement in drug trafficking.
- 25. On 10.05.2022, sanction for prosecution for filing the charge sheet against 14 accused persons was accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967.
- 26. Kannur (Kerala) Airport has been included in the list of authorized ICPs for entry of persons holding e-Visa.
- 27. Provisioning sanction of Rs. 204.19 crore and Expenditure sanction of Rs.28.84 lakh have been accorded to CAPFs for procurement of vehicles, other equipments etc.
- 28. Guidelines of the scheme of Modernization Plan IV of CAPFs to be implemented till 31.03.2026 with the total outlay of Rs. 1523 Crore has been issued on 25.05.2022,
- 29. Sanction for foreign visit has been accorded on 12.05.2022 for a delegation of CRPF to witness onsite demonstration/trial of Multi Mode Passive Detection System (MMPDS) at the premises of M/s Decision Sciences in California, USA from 17.05.2022 to 20.05.2022.
- 30. Following change of names were effected: (i) the name of Shri "Flargobincipur City" as "Shri Hargobindpur Sahib" in Punjab; (ii) name of the village "Kachrewadi" Tal-Tasgaon, District Sangli as "Limbgaon" in Maharasthra; (iii) name of the village "Melmuri" in Tirur Taluk in Malappuram District as "Kclampuzha" village; (iv) name of "Nsunyu" village to "Kithagha" village in Tseminyu Sub-Division under Kohima District Nagaland; and (v) name of village "Acharra" as "Acharya Dham" in Tikamgarh District, Madhya Pradesh.
- 31. 12th Meeting of Standing Committee of the Southern Zonal Council held on 28.05.2022 in Thiruananthapuram, Kerala.
