Sir/Madam,

The undersigned is directed to refer to this Ministry's letters of even number dated 15.07.2020 and 18.08.2020 regarding above mentioned subject. The competent authority has approved to conduct 05 days pre-UN SAAT training at National UN CIVPOL Centre, 22nd Battalion, ITBP, Tigri Camp, New Delhi from 04th January, 2021 in various batches(schedule is enclosed for each batch).

2. The State Governments, UT Administration, Directors, Directors General (Police/CAPFs/CPOs), Commissioners of Police are requested to direct their respective nominated officers to report at the **National UN CIVPOL Centre**, **22**nd **Bn ITBP**, **Tigri**, **Madangir**, **New Delhi** one day prior to the commencement of training as per the schedule mentioned in the enclosed list. The officers will carry with them 9mm pistol and 50 rounds of 9mm cartridge for firing practice along with a pair of Uniform of respective organization. The officers may be instructed to be available during nominated training batch; in case they fail to report, the officers will not be allowed in another batch.

3. It is observed that requisite bio data, EASP and vigilance clearance and NOC from their Home Departments/States from their respective departments are not received along with the nominations of a few officers. As such, all concerned officers may be directed to submit the above documents at the time of reporting at National UN CIVPOL Centre, ITBP, Tigri Camp, New Delhi. It will be the responsibility of sponsoring organization to ensure that the nominated officers fulfill the all eligibility conditions circulated by this Ministry's communication dated 15.07.2020.


