Excellencies,

I am writing to provide guidance, further to my note of 21 February 2020, to all troop- and police-contributing countries (T/PCCs) and field operations on travel constraints imposed in light of the novel coronavirus disease (COVID-19) outbreak and the impact to peacekeeping missions and special political missions.

The current outbreak of COVID-19 continues to expand with reported cases across more than 78 countries. Experience to date shows that majority of patients would have mild disease and recover. The virus may, however, have an exacerbated impact on those most vulnerable, including people without access to medical care and who may have an existing underlying condition.

While there are no reported cases of the virus in any UN field operations, recent guidance received from several Member States will require us to suspend or postpone certain planned deployments or rotations of military and police personnel to UNMISS, MONUSCO, UNISFA and UNIFIL.

I thank you for your continued support in helping us mitigate against any spread of COVID-19 in our missions.
