
Office Memorandum

Sub: Extension of the tenure of the Finance Commission for UTs of Andaman & Nicobar Islands, Dadra & Nagar Haveli and Daman & Diu, Ladakh and Lakshadweep

The undersigned is directed to refer to this Ministry's Notification No. S.O. 5417(E) dated 21.12.2023 and convey to that, vide this Ministry's Notification No. S.O. 4184(E) dated 24.09.2024 (copy enclosed), the tenure of the Finance Commission for UTs of Andaman & Nicobar Islands, Dadra & Nagar Haveli and Daman & Diu, Ladakh and Lakshadweep has been extended for three months beyond 30.09.2024 i.e. from 01.10.2024 to 31.12.2024.
