**Record of Discussions of the Meeting of Nodal Officers of States and UTs  
dealing with Human Trafficking held on 17<sup>th</sup> August, 2022**

\*\*\*\*\*

A meeting of the Nodal Officers of all States and Union Territories dealing with Human Trafficking was convened by the Ministry of Home Affairs under the chairpersonship of Additional Secretary (WS), Ministry of Home Affairs on 17.8.2022 through virtual mode.

2. Besides the officers of the States and UTs, representatives of the Ministry of Women & Child Development, Ministry of External Affairs (Protector of Emigrants), Ministry of Labour and Employment, National Investigation Agency, National Crime Records Bureau, Bureau of Police Research and Development, Sashastra Seema Bal, Border Security Force, and Railway Protection Force were also invited to the meeting.
3. Initiating the discussions, AS (WS) welcomed the participants and gave an outline of the subject and the issues to be discussed during the meeting. Since the meeting was being held after a gap due to the Covid-19 situation, Deputy Secretary (PR & ATC), MHA was requested to make a presentation on the subject with a view to update the Nodal Officers about various issues involving human trafficking viz. constitutional/statutory provisions, details of MHA's initiatives in preventing and combating human trafficking, scheme of upgrading/setting up Anti-Human Trafficking Units (AHTU), and major points of discussion with the States and UTs, etc.
4. During the presentation, the following points were highlighted and the States and UTs were requested to provide their inputs/ feedback thereon:
  - a) The Government of India recognizes that Human Trafficking is a grave crime and attaches high importance to the efforts directed at preventing and countering human trafficking.
  - b) Human Trafficking is a highly organized crime often involving interstate gangs.
  - c) By Criminal Law (Amendment) Act, 2013, Section 370 of the Indian Penal Code was substituted with a modified Section 370 and a new Section 370 A was also inserted. These Sections provide comprehensive definition of human trafficking and also provide for strict punishment to be awarded to the offenders for exploitation of a trafficked person.
  - d) Following Sections of Indian Penal Code are also relevant in the context of trafficking in persons:
    - Section 366-A: Procurement of minor girls
    - Section 366-B: Importation of girls from foreign country
    - Section 372: Selling of girls for prostitution
    - Section 373: Buying of girls for prostitution
  - e) **Other legislations which deal with trafficking related crimes are:**
    - The Immoral Traffic (Prevention) Act, 1956.

- The Prohibition of Child Marriage Act, 2006
  - The Child Labour (Prohibition and Regulation) Act, 1986
  - The Bonded Labour System (Abolition) Act, 1976
  - The Juvenile Justice (Care and Protection of Children) Act, 2015
  - The Transplantation of Human Organs and Tissues Act, 1994
  - Protection of Children from Sexual Offences (POCSO) Act, 2012
- f) 'Police' and 'Public Order' are 'State-List' subjects under the Seventh Schedule to the Constitution of India. Therefore, the primary responsibility to maintain law and order, as well as prevention, investigation and prosecution of the crime of human trafficking vests with respective State Governments, who are competent to deal with such offences under extant provisions of law.
- g) Given the fact that Human Trafficking is a serious crime, the Government of India has been supplementing the efforts of the State Governments to address the issue in a comprehensive manner by way of the following measures/ initiatives:
- An Anti Trafficking Cell has been established in MHA since 2006, which acts as an interface with all Central Ministries/Departments and the State/UT Governments in addressing the issue of human trafficking.
  - Establishment of AHTUs – The Government of India through its scheme under "Nirbhaya Fund" has supported the States and UTs in establishing/ upgrading AHTUs covering all Districts of the States and UTs and has released financial assistance to all States and UTs.
  - Regular Advisories are issued to States and UTs sharing guidelines on preventing and countering human trafficking.
  - Support by MHA to States and UTs for holding Judicial Colloquiums and State Level Conferences to sensitise State officers.
  - Ratification of multilateral treaties and signing of bilateral agreements are done by MHA to coordinate with international partner countries.

5. Key points emphasized during the presentation:

- a) It has been noted that concerned officers in States and UTs sometimes lack awareness and training, and at times fail to register cases **under relevant Sections of IPC**, resulting in ineffective prosecution/conviction rate, etc.
- b) Motivating and updating the knowledge base of the officers dealing with human trafficking is considered essential, for which States need to make special efforts and provide them adequate training and resource material etc. on periodic basis. In case the States need any specific training resources, the same can be organised by the Bureau and Police Research Development, for which a request can be made to them.
- c) Strengthening cooperation and establishing inter-state channels of communication is essential, which the States and UTs need to work in close coordination with each other.
- d) An Institutional mechanism to counter human trafficking in a focussed and effective manner at the level of State/UT Governments was devised and shared by MHA with all States and UTs through an Advisory dated 1<sup>st</sup> December, 2020,

vide which the States were asked to establish appropriate Bureau/Units at different levels in the States/UTs -

- i. Anti Human Trafficking Bureau at **State-Headquarter level** – headed by an ADG level officer
- ii. Establishment of AHTUs in every district of the State/UT.
- iii. Women Help Desk in every Police Station of the State/UT.

States and UTs are requested to look into this issue and facilitate establishment of such Units at all three levels, if not done already.

e) MHA had issued an Advisory on 6<sup>th</sup> July, 2020, whereby important guidelines were shared with the States and UTs and they were requested to:

- i. Evolve appropriate **coordination mechanism** among various departments in the States and UTs.
- ii. **Awareness generation** at all levels – Panchayat, Taluka, Districts, etc.
- iii. Engage with the representatives of **local Panchayats**, community leaders, Village Watch and ward, Municipal Committees/Neighbourhood Committees/ RWAs etc.
- iv. **Intelligence** and surveillance mechanism to identify gaps.
- v. **Training and sensitization** of Police officers handling human trafficking cases at regular intervals.

States and UTs are requested to take note of the guidelines provided in the Advisory.

f) A national level communication platform - **Crime Multi Agency Centre (Cri-MAC)** was launched in March 2020. Cri-MAC facilitates dissemination of information about significant crimes including human trafficking across the country on real time basis and enables inter-State coordination. This can, inter-alia, help in locating and identifying the trafficked victims as also in prevention, detection and investigation of crimes.

g) MHA supports the States to organize Judicial Colloquiums and State Level conferences to sensitize the judicial officers and law enforcement agencies and key stakeholders on wide-ranging issues relating to trafficking in persons. MHA provides Rs 2 lakh for holding Judicial Colloquiums/ State Level conferences. States are requested to organize Judicial Colloquium and State Level Conferences regularly.

h) States/UTs are requested to sensitize and train police personnel posted at important transport hubs such as bus depots/railway stations/State borders etc. to keep a close watch on suspicious activities/persons.

i) The Ministry of Labour & Employment is requested to sensitize officers of the Labour Department of all States and UTs for keeping a close watch on the activities of suspicious placement agencies.

j) Organising awareness generation campaigns by the States and UTs on a regular basis is considered essential as generating awareness is key to preventing trafficking activities.



k) It is noted that human trafficking cases are not registered under Sections 370/370A of IPC by some Police authorities. States/UTs are requested to make optimal use of these Sections for registering human trafficking cases. Nodal Officer at State Hqrs level may suitably brief the concerned officers in this regard.

6. Representatives of all States and UTs except Nagaland, Kerala, Tamil Nadu, Jammu and Kashmir, Daman Diu and Dadra Nagar Haveli, Lakshadweep provided inputs on the issues raised by MHA.

7. Based on the inputs received from the States and UTs as well as the discussions held during the meeting, the following major action points have emerged:

- (i) Use of Cri-MAC application for inter-state coordination amongst law enforcement agencies of all States and UTs needs to be encouraged. Those States and UTs, who are not using Cri-MAC regularly are encouraged to make use of this IT intervention to coordinate action amongst states in sharing inputs and alerts on trafficking incidents. A snapshot of the details on the usage of Cri-MAC application by the States and UTs as on 1.7.2022 is attached. **A User Manual for Crime Multi Agency Centre** developed by National Crime Records Bureau is also attached for the guidance of States and UTs to facilitate regular use of Cri-MAC application.
- (ii) States and UTs in which AHTUs have been established may provide the names of all Districts where AHTUs have been established. Details may be shared at email ID: [dspr.atc@mha.gov.in](mailto:dspr.atc@mha.gov.in).
- (iii) States/UTs to furnish Utilisation Certificate of the financial assistance provided for setting up/strengthening AHTUs. Some States and UTs had informed that they have provided UCs to MHA. However, since many of these UCs have not been received in MHA, the following States and UTs are requested to **re-send the UCs** even if these were sent by them earlier:

[Action: State/UT of Andhra Pradesh, Arunachal Pradesh, Assam, Bihar, Goa, Gujarat, Himachal Pradesh, Jharkhand, Kerala, Madhya Pradesh, Maharashtra, Manipur, Nagaland, Odisha, Punjab, Rajasthan, Tamil Nadu, Tripura, West Bengal, Delhi, Jammu & Kashmir, Puducherry, Andaman & Nicobar Islands, Chandigarh, Dadra & Nagar Haveli and Daman & Diu, Lakshadweep and Ladakh]

- (iv) The complete details of Nodal Officers of AHTUs at State/UT-Headquarter level have not been received from the following States/UTs and may be sent to MHA on urgent basis:

[Action: State/UT of Andhra Pradesh, Arunachal Pradesh, Maharashtra, Manipur, Punjab, Rajasthan, West Bengal, Delhi, Puducherry, Jammu & Kashmir and Ladakh]

- (v) States/UTs may share the SOPs being used by them in effectively handling Human Trafficking for the **benefit of other States/UTs** as part of sharing best practices and knowledge sharing with partners.

(vi) Special focus to be placed on curbing the illicit activities of suspicious placement agencies involved in human trafficking. All States and UTs to coordinate with the Labour Department of the State/UT.

8. All concerned States/UTs are requested to take note of the above issues for appropriate action.

9. During the discussions, some States had projected their requirement for additional funds for setting up AHTUs in newly created districts. They were advised to convey their proposal to MHA for consideration.

The meeting ended with a vote of thanks to all the participants.

## 1. Introduction to Cri-MAC

Multi Agency Centre (MAC) in Intelligence Bureau was developed to share timely inputs among various stakeholders involved in law enforcement. Similarly, it was envisaged to establish Crime Multi Agency Centre (Cri-MAC) under NCRB for online sharing of information on crime & criminals on 24x7 basis with various Law Enforcement Agencies and ensure seamless flow of information between them. Cri-MAC intends to improve the digital communication between disjointed units as this will lead to better and faster coordination. This will help in early detection and prevention of crime incidents across the country. Cri-MAC application is web based application and runs on secured network (CCTNS network). Only authenticated ICJS users can access the application. It cannot be accessed through open public network.

### Features

- Scrolling windows on recently occurred important crime incidents like Human Trafficking, Jail Breaks, Wanted or Arrest of interstate criminals, Important seizures & recoveries and Jail releases, etc.
- A separate window to raise high alerts, like Hue & Cry notices etc.
- Inter communication among police stations through E-mail and SMS for various logistic purposes or crime co-ordination.
- Provision for FIR based and text based searches in different windows over legacy data.
- In each alert, link to the case details, clicking on which will fetch FIRs etc. from the CCTNS/ICJS database.
- Information Upload - Information in different windows to be uploaded by Police Stations, Higher Offices, Prisons and other pillars of criminal justice system via access rights.

## 2. Cri-MAC Web Application (Cri-MAC)

Using Cri-MAC application, a user can view alerts, upload new alerts, search for an alert and communicate with others through e-mail and SMS. The modules present in the application are:

- i. Login
- ii. Dashboard
- iii. Upload Data
- iv. Search Data
- v. Message (E-mail and SMS)

## i. Login

Cri-MAC can also be accessed through Digital Police Portal (<https://digitalpolice.gov.in>)



The Login screen comes wherein the user has to specify the user name and password. Only users, who have the login credentials in ICJS portal can login to the Cri-MAC application.

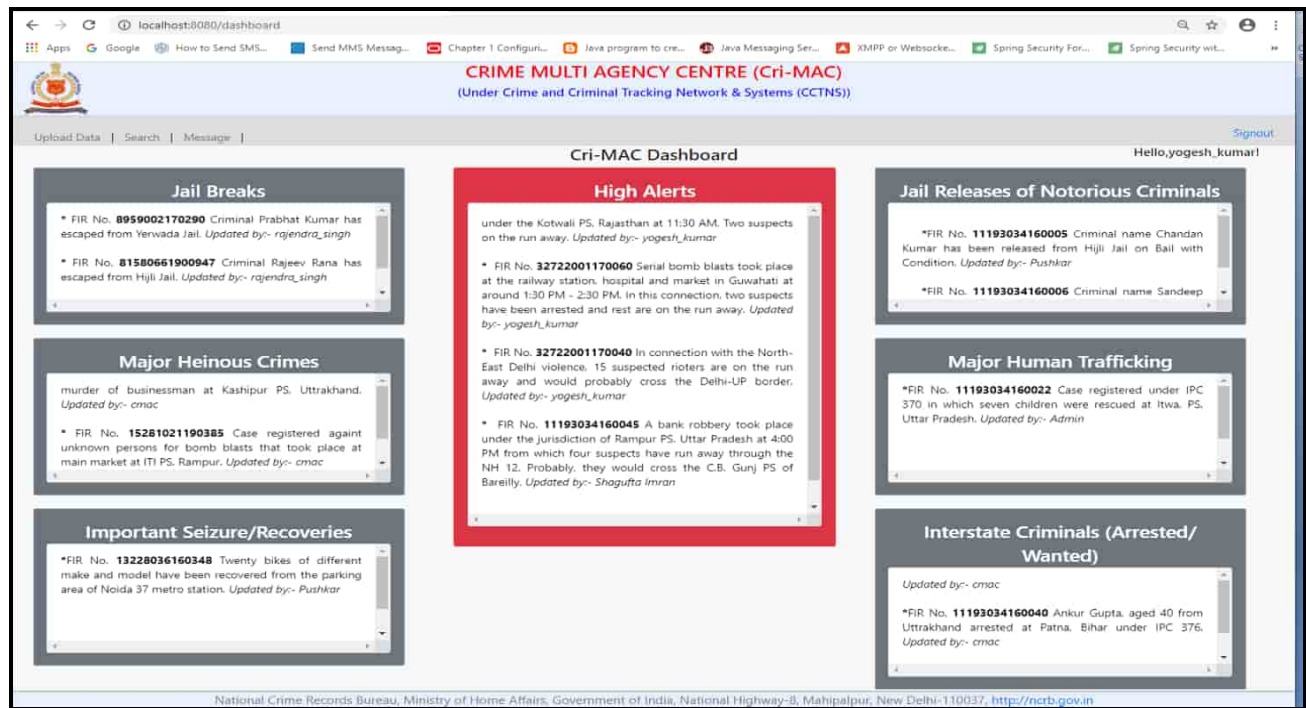




## ii. Dashboard

The first screen that comes when a user logs in to Cri-MAC is the Dashboard. The dashboard displays alerts on scrolling windows on recently occurred important crimes on the following categories:

- High Alerts
- Major Heinous Crime
- Major Human Trafficking
- Jail Breaks
- Jail Releases
- Important Seizures & Recoveries
- Interstate Criminals (Arrested/Wanted)



Text in the scrolling windows has links to the case details. The user can click on the FIR number associated with each alert to view the details of the FIR. The FIR details are shown as below:

### iii. Upload Data

When the user clicks on Upload Data, a new screen comes wherein a new alert under different categories can be uploaded by providing the following details:

- a) FIR number
- b) Category of alert
- c) Descriptions
- d) Attachment(s), if any, maximum of five attachment files are allowed. The types/formats of files which can be uploaded are: .jpg, .png, .tiff, .doc, .docx, .xls, .xlsx, .pdf

#### iv. Search Data

The user can search for an existing alert from the Search page based on the following:

##### Search by FIR number

If the user knows the FIR number, click on the Search by FIR No. radio button and enter the FIR number. Then click Search.
