- Utilisation certificate shall be furnished in format GFR-12 C as per the provisions of GFR-2017. The other codal formalities as prescribed in GFR-2017 shall also be adhered to strictly.
- The accounts of grantee institutions will be open to audit by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry.
- The UT Administration are responsible to utilize the sanctioned grants-in-aid in accordance with the enclosed Guidelines.
