**Sub: Enhancement of Delegation of financial powers under head "Reward" to DsG/other authorities of the CAPFs, AR & NSG – reg.**

In supersession of all earlier orders on delegation of financial powers to DsG/other authorities of the CAPFs, AR & NSG pertaining to "Reward", sanction of the Competent Authority is hereby accorded to revised the delegation of financial powers as per following details:

Authority	Existing Delegation of Financial Powers	Revised Delegation of Financial Powers
DG	Rs.10,000/- in each case with an over ceiling of	Rs.12,000/- in each case with an over ceiling of Rs.3 Lakh p.a.
SDG/ADG	Rs.2.50 Lakh per annum	Rs.10,000/- in each case with an over ceiling of Rs.1 Lakh p.a.
IG	Rs.2,500/- in each case	Rs. 2,500/- in each case with an over ceiling of Rs.50,000/- p.a.
DIG	Rs. 500/- in each case	Rs.1,000/- in each case with an over ceiling of Rs.30,000/- p.a.
Commandant	Rs.300/- in each case	Rs.500/- in each case with an over ceiling of Rs.20,000/- p.a.

2. All the above mentioned delegated powers shall be exercised in consultation with the IFA/FA of the Force/Organization.
3. These delegated powers will be effective from the date of issue of this order.
4. This issues with concurrence of Integrated Finance Division of this Ministry vide E-CF No. 3605908 dated 26.11.2025 and approval of the Union Home Secretary.
