

1. **Security Related Expenditure (Police)-SRE(P) Scheme:** This scheme was introduced in 1989-90 for supporting the logistical requirements of the police force of J&K in order to combat militancy in the State. It provides for 100% reimbursement of expenditure. 60% amount is reimbursed upfront on receipt of claims and remaining 40% is released after receipt audit report. It broadly covers carriage of constabulary, logistic support for security forces(SFs), honorarium of SPOs, IR battalions, civic action plan for J&K Police, creation and up-gradation of infrastructure like construction of alternate accommodation for security forces so that they can vacate public and private buildings etc. Financial year wise reimbursement made to the Govt, of J&K under the scheme is tabulated below:

2. **Security Related Expenditure (Relief and Rehabilitation)-SRE (R&R) Scheme:** This scheme was also introduced in 1989-90 for supporting the relief and rehabilitation of the Kashmiri migrants who have been uprooted from the Valley during the militancy period besides other relief & rehabilitation measures. It provides for 100% reimbursement. 60% amount is reimbursed upfront on receipt of claims and remaining 40% is released after receipt audit report. It broadly covers relief to Kashmiri and Jammu migrants, expenditure incurred on PM's package for return and rehabilitation of Kashmiri migrants, relief to NoKs of civilians/security personnel killed in militant related attacks, rehabilitation of surrendered militants etc. Financial year wise reimbursement made to the Govt, of J&K under the scheme is tabulated below:

3. **SRE (J&K) Security Environment** : Under the SRE(SE) Scheme, the Government of India is providing funds to CAPFs, J&K Police and SRC, Social Welfare Department, Govt. of UT of J&K for organizing Bharat Darshan Tour / Watan Ko Jano tours and Youth Exchange programme to give exposures to the youths and children of J&K about the cultural and socio-economic development taking place in other parts of the country.

Major activities of the Scheme:

- a) Conducting Bharat Darshan /Watan-Ko-Jano Tours Programme: Bharat Darshan /Watan Ko Jano tours and Kashmiri Youth Exchange Programme are organized with the help of all the CAPFs, J&K Police and Social Welfare Department, Govt. of UT of J&K and Nehru Yuva Kendra Sangathan (NYKS). So far, about 35,000 persons have been benefited under this Project. Every year, an approx. amount of Rs.8.00 crore is released for about 5000 persons.
- b) Civic Action Programme (CAP) activities: Civic Action Programme is being implemented with the help of CAPFs under which various activities are conducted including conducting Medical Camps, Veterinary Camps, vocational training and skill development programmes for youth, sports and cultural activities etc. in the UTs of J&K and Ladakh. Every year, an approx. amount of Rs.7.00 crore is released for about 1.5 lakh beneficiaries every year under this programme.
- c) Women Empowerment through Self Employed Women's Association (SEWA): Releasing grant-in-aid to SEWA for establishment of their resource centers in J&K and

Ladakh. In the year 2023-24, new proposal of SEWA for expansion on various activities in Budgam, Baramullah Bandipora districts of Jammu and Kashmir and 40 villages of Ladakh amounting to Rs.6.65 Crores was approved for three years out of which Rs.2.21 Crore has been released as first instalment in 2023-24.

Subject: Guidelines for Security Related Expenditure (SRE) for J&K schemes.

The Umbrella scheme of 'Modernization of Police Forces (MPF)' was approved by the Cabinet Committee on Security (CCS) on 29.09.2017. Three schemes, being handled by Department of Jammu and Kashmir Affairs, namely SRE(J&K): Police; SRE(J&K): Relief and Rehabilitation (R&R) and SRE (J&K): Security Environment (SE) are part of the Umbrella scheme on MPF.

2. Background:

In pursuance to the acceptance of the Report of the SRE Parameters Review Committee by the Government and decisions taken by the SRE Standing Committee, an Order No.17012/5/98-K(DO-1) dated 10-6-1999 was issued, which contained items for which and norms with which, reimbursement was to be made under SRE to the Governments of Jammu and Kashmir and Himachal Pradesh. The scheme came into effect from the financial year 2000-01 (i.e. from 01-04-2000) and onwards. 100% fund was reimbursed under the SRE.

3. Advent of the Umbrella Scheme:

The Umbrella scheme of 'Modernization of Police Forces (MPF)' was approved by the CCS on 29.09.2017. Under the Umbrella Scheme, **SRE(J&K): Police** is a State sector sub-scheme with funding Centre:State::90:10; **SRE(J&K): R&R** and **SRE(J&K): SE** are Central sector sub-schemes with 100% funding by Central Government. The total outlay is Rs.1710 crore for SRE (J&K): Police; Rs.1900 crore for SRE(J&K): R&R and Rs.56 crore for SRE(J&K): SE for three years i.e. from 2017-18 to 2019-20. The details of these Schemes are annexed.

4. SRE Standing Committee:

The SRE Standing Committee was constituted in 1998 vide order no.17012/5/98-K(DO.I)-Vol.II dated 23.02.1999 under the chairmanship of Special Secretary (J&K), Department of Jammu and Kashmir Affairs with the member of representative of State Govt., Department of Expenditure, IFD-MHA and J&K division for considering and harmonious settlement of all matters relating to reimbursement of SRE to the State of Jammu and Kashmir. The Committee is to examine and approve various proposals relating to SRE received from State Govt. from time to time as also to effectively monitor SRE releases and consider "advance release of SRE". The revised composition of the SRE Standing Committee is at Annex.-A.



5. Competent Authority for inclusion/ exclusion of items:

After the recommendation of SRE Standing Committee, the approval of Union Home Minister is required for inclusion/ exclusion of items under all three schemes within the limit of approved budget allocation.



4. Funding Pattern:

The funding pattern under the scheme would be Centre : 90 and State : 10.
The funding would be regulated as under:-

- (i) All SRE releases should be reimbursed after verifying claims of State Government.
- (ii) 60% of the claim amount for approved items may be released on the certification given by an officer of State Government not below the rank of Additional Secretary of the State Government.
- (iii) 30% of the claim amount may be released on the basis of the recommendation of audit team of IAW (IFD-MHA).
- (iv) 10% of claim amount may be borne by State Govt.
- (v) The SRE account would be subject to audit by the State AG. The expenditure certified by State AG will be treated as final and based on this, reimbursement from GOI will be adjusted in future reimbursements, if required.

5. Advances under SRE(J&K): Police

With the approval of SRE Standing Committee, advance release may be considered in special circumstances.

In addition to above, advances for first quarter of a financial year (while previous year's accounts are being finalized) may be released.

6. Proforma for Claims:

The Claims for reimbursement of Security Related Expenditure should be furnished in the prescribed proforma as at Annex-B, duly certified by an Officer not below the rank of Additional Secretary to the concerned State Government.

7. Review of accounts/expenditure

Ministry of Home Affairs may send 'teams' to the concerned State from time to time, to carry out sample checking of the SRE accounts being maintained by the State, to discuss any problems related to release of SRE, including reconciliation of accounts, and to review the impact of utilization of SRE.

- (i) The concerned States may therefore keep ready the complete details of expenditure under each and every item, such as Administrative sanctions, bills/vouchers, Location/site of constructions, Details of beneficiaries, details of Spending Authority, Certificates from the Spending Authority in respect of each head of expenditure, etc.
- (ii) The above review would be over and above the normal audit by Internal Audit Wing (IAW) of IFD-MHA which will audit the record of expenditure of State Govt. in the month of April- June for the accounts of the period from 1st October of previous year to March of the year and in the month of October-December for the accounts of the period from 1st April of the year to September of the year.



SRE (J&K): Relief and Rehabilitation

In view of the serious militancy in J&K, the Govt. of J&K have to incur more expenditure for maintaining peace and tranquility. For this purpose, a separate Scheme namely SRE (Relief and Rehabilitation) (R&R) was introduced in 1989-90.

2. The scheme envisages reimbursing the expenditure incurred by the State Government of Jammu and Kashmir towards Relief and Rehabilitation activities broadly categorized under the following heads belonging to different categories/class of affected people.

- (i) Relief to Kashmiri and Jammu Migrants settled in J&K and Delhi in the form of cash or kind.
- (ii) Expenditure towards providing employment to Kashmiri migrants announced from time to time by Gol under special packages.
- (iii) Financing Rehabilitation activities related to migrants like construction of Transit accommodations, Housing facilities, Scholarships, Providing Employment, Waiving of interest on loans, Assistance to farmers etc
- (iv) Ex-gratia to be extended to NoK of JKP, CPMF, Army and SPOs deceased due to violence
- (v) Relief and other safeguarding activities to be extended to Border population
- (vi) Expenditure towards Rehabilitation activities to be taken up under Surrender Policy
- (vii) Relief measures to be extended to the victims of cross border firing/terrorism/law&order/militancy etc
- (viii) Any other issue not covered by above classification but pertains to Relief and Rehabilitation activities concerned with the population of J&K and as deemed fit by the Gol.



4. Funding Pattern:

The sanction orders will be issued by the Department of Jammu and Kashmir Affairs, MHA, subject to certain conditions/guidelines related to the type of financial assistance being extended from time to time.

The schemes/projects would be funded 100 % by Central Govt. The funding would be regulated as under:-

- (i) All SRE releases should be reimbursed after verifying claims of State Government.
- (ii) 60 % of the claim amount for approved items (except those where DBT is used as a means of disbursement) may be released on the certification given by an officer of State Government not below the rank of Additional Secretary of the state government.
- (iii) 40% of the claim amount may be released on the basis of the recommendation of audit team of IAW (IFD-MHA).

- (iv) Wherever DBT is used as means of disbursement, 100% of the claim amount will be reimbursed subject to the certification given by an officer of State government not below the rank of Additional Secretary of state government.

5. Advances under SRE(J&K): R&R

With the approval of SRE Standing Committee, advance release may be considered in special circumstances.

In addition to above, advances for first quarter of a financial year (while previous year's accounts are being finalized) may be released.


6. Proforma for Claims

The Claims for reimbursement of Security Related Expenditure should be furnished in the prescribed Proforma as at Annex-C, duly certified by an Officer not below the rank of Additional Secretary to the concerned State Government.

7. Review of accounts/expenditure

SRE (J&K): Security Environment

12 (A)

In view of the serious militancy in J&K, the Govt. of J&K have to incur more expenditure for maintaining peace and tranquility. For this Govt. of India is also incurring expenditure to carry out the various activities through CAPFs as well as through NGOs to win over the heart and mind of the people of J&K by bringing them into mainstream. The aim of the programme is to show the youth/children of J&K the social and cultural diversity of the country and make them socially and emotionally integrated with the rest of the country.

2. List of Items covered under SRE(J&K): SE

- (i) Organizing Medical Camps
- (ii) Organizing sports events/ tournaments
- (iii) Adoption of Schools for their facility improvement etc.
- (iv) Organizing Coaching Classes for the youth for preparing them for written and physical tests for recruitment in security forces;
- (v) Organizing vocational training, career counseling programmes for youth
- (vi) Organizing Bharat Darshan Tour / Watan Ko Jano Program
- (vii) Organizing Cultural Programmes/ Activities;
- (viii) Establishing and supporting Youth Clubs;
- (ix) Programmes for promotion of Government's narratives on various sites/platforms;
- (x) Holding Conferences/ Seminars/ Workshops;
- (xi) Program of Women Empowerment through NGO/ CAP
- (xii) Providing assistance during natural calamities
- (xiii) Any other issue not covered by above classification but pertains to Security Environment activities.


3. Funding Pattern: The Scheme will be funded 100% by Central assistance.

4. Advances under SRE(J&K)- Security Environment

All the funds under the Scheme would be released in advance subject to the receipt of the Utilization Certificates (UCs) for the previous year. The concerned organizations are required to submit UCs in conformity with Rule-239 of GFR 2017 in the prescribed format i.e 'Form GFR 12-C' (Annex.-III). The expenditure certified by State AG will be treated as final and based on this, reimbursement from GOI will be adjusted in future reimbursements, if required.

5. Review of accounts/expenditure

As per GFR Rule 211 (1), the accounts of the CAPFs / NGO shall be open to inspection / audit/ review by the sanctioning authority and by Internal Audit Wing (IAW) of MHA, whenever the organization is called upon to do so.

2. List of Items covered under SRE(J&K): Police

A. Jammu and Kashmir:

I. Carriage of Constabulary (CoC)

This includes the cost of petrol/diesel and hiring of vehicles provided for mobilization of State police as well as CAPFs deployed in the State of J&K to combat the militants.

II. Material and Supplies including Machinery & Equipments

This includes expenditure on account of purchase/ supply of various materials including security related Machinery & Equipment.

III. Rent of accommodation hired for Security Forces

(a) Various units of Central Para-Military Forces (CPMFs) as well as the State Police are provided with the accommodation for which the Government of J&K hires hotels, private residence, shops, godowns and lands for tents etc.

(b) This includes expenditure on account of rent of accommodation hired for Security Forces.

IV. Additional Police Battalions

(a) 10th IR Bn. sanctioned.





VI Honorarium to Special Police Officers (SPOs)

(a) In view of the militancy, Government of India has sanctioned the engagement of Special Police Officers in the Police Department of J&K from time to time.

(b) SPOs (Gr.I - 2274) and SPO (Ordinary Grade 23200) (Total - 25474) merged into Single Category and the rate of honorarium in respect of



Gr.I @ Rs.24,000/- per year and in respect of Ordinary Grade @ Rs. 18,000/- per year increased to Rs.36,000/- per year per SPO w.e.f. 01.09.2006 (plus @ Rs.2000/- per SPO per annum towards training, weapons and equipment etc.).

(c) Additional 5000 SPOs deployed for a period of one year w.e.f. 28.12.2007, raising the total sanctioned strength from 25474 to 30,474.


VIII Construction of accommodation for Security Forces. (Alternate Accommodation)

This includes expenditure on construction of accommodation for security personnel of Central Para-Military Forces (CPMFs) deployed in the state to combat the militancy so that the establishments (hotels, schools, office buildings, factories etc.) occupied by these forces could be vacated.

IX Expenditure on transport/boarding/lodging of employees working in security zones.

X Civic Action Programmes for J&K Police (as per approved norms/guidelines issued by DJKA/MHA.

To improve the relation of Police with public.

XI Airlift charges

(a) Air Courier Services:

This includes expenditure on air courier services for the safe movement of CAPF Personnel in J&K so as to decongest the national highway and to avoid security issues relating to large scale convoy movements.

(b) Helicopter Services:







SRE (J&K): Relief and Rehabilitation

In view of the serious militancy in J&K, the Govt. of J&K have to incur more expenditure for maintaining peace and tranquility. For this purpose, a separate scheme namely SRE (Relief and Rehabilitation) (R&R) was introduced in 1989-90. Under this scheme, funds are reimbursed to the State Government of Jammu and Kashmir.

2. This scheme envisages reimbursing the expenditure incurred by the State Government of Jammu and Kashmir towards Relief and Rehabilitation activities broadly categorized under the following heads belonging to different categories/classes of affected people:

i. Relief to Kashmiri and Jammu Migrants settled in J&K and Delhi in the form of cash and kind.

(a) Cash relief to Kashmiri and Jammu migrants settled in J&K: Rs. 3250/-per head per month subject to a ceiling of Rs.13000/- per family per month w.e.f. 13.06.2018

(b) Cash relief to Kashmiri migrants settled in Delhi/NCR: Rs. 3250/-per head per month subject to a ceiling of Rs.13000/- per family per month w.e.f. 01.08.2018.

The ceiling of Rs. 10 lakhs will be apportioned and subject to an upper ceiling of Rs. 7 lakhs in respect of immovable property and Rs. 3 lakhs in respect of moveable property respectively.







The SRE Standing Committee was constituted in 1998 vide Order no.17012/5/98-K(DO.I)-Vol.II dated 23.02.1999 under the chairmanship of Special Secretary (J&K), Department of Jammu and Kashmir Affairs with the member of representative of State Govt., Department of Expenditure, IFD-MHA and J&K Division for considering and harmonious settlement of all matters relating to reimbursement of SRE to the State of Jammu and Kashmir. The Committee is to examine and approve various proposals relating to SRE received from State Govt. from time to time as also to effectively monitor SRE releases and consider "advance release of SRE". The composition of the SRE Standing Committee has been revised keeping in view of the fact that the Union Home Minister is now vested with the power for inclusion/ exclusion in the SRE as per the cabinet approval and therefore the representative of Ministry of Finance as member of SRE Standing Committee has been omitted. The revised composition is as under:-

2. The terms of reference of the Committee shall remain unchanged which is as under:-

- (a) To go into the detailed norms for each of the approved activities for which reimbursement is being made.
- (b) To effectively monitor SRE release as well as maintenance of accounts, through periodic reviews.
- (c) To examine and approve, within the overall guidelines, various proposals relating to SRE received from State Government from time to time.
- (d) To finalize/approve annual work programme/plans of those items, for which recommendations has been made by the SRE Parameters Review Committee 1993 that work the undertaken after the approval of SRE Standing Committee.
- (e) To go into the questions like the number of SPOs for whom Government of India should reimburse SRE, by assessing the district wise requirements of SPOs and duties to be taken up by SPOs, based upon the changing security scenario in the State, and to approve the actual number of SPOs for which reimbursement is to be made.
- (f) To consider and approve proposals of State Government in respect of arrears, if any, other than those for which SRE Parameters Review Committees 1998 has already made recommendation.
- (g) To consider and authorize 'advance release of SRE' in respect of cases which merit advance release rather than reimbursement.
- (h) To consider any other matter related to SRE, which the Committee think fit.

3. The committee shall meet at least twice in a year more frequently if necessary.
