
Sub: Information sought by Shri Rajender Singh Dahiya under section 6 of the RTI Act, 2005- regarding.

Point No. 01 & 02:- The applicant is informed that the questions as asked by him pertain to the year 1987 and the matter is very old. The relevant records are not readily traceable in the UTS-II Desk, MHA. From the application, it is not clear whether the applicant was inducted to DANIPS. Hence, it is not possible for the Ministry to provide the desired information. However, the instant RTI application is being transferred to the Delhi Police for necessary action under section 6 (3) of the RTI Act, 2005.



Sir,


