## NOTIFICATION

U.S.R. 108 ... In exercise of the powers conferred by section 87 of the Punjab Recreanisation Act, 1966 oy section 87 of the Funjab Reorganisation Act. 1965 (31 of 1966), the Gentral Government hereby extends to the Union territory of Chandigath, the Punjab to the Union territory of Chandigath, the Punjab Professions, Trades, Callings and Employments Taxation (Haryana Amendment) Act, 1966 (Haryana Act No. 1 of (Haryana Amendment) act, 1966 (Haryana, subject 1967), as in force in the State of Haryana, subject to the following modifications, namely:

THE PUNJAB PROFESSIONS, TRADES, CALLINGS AND EMPLOY, MENTS TAXATION (HARYANA AMENDMENT) ACT, 1965 AS EXTENDED TO THE UNION TERRITORY OF CHANDIGARA

( HARYANA ACT No. 1 of 1967 )

An Act to amend the Punjab Professions, Trades, Callings and Employments Taxation Act, 1956.

Be it enacted by the Legislature of the State of Haryana in the Seventeenth Year of the Republic of India as follows:-

- 1. Short titles This Act may be called the Punjab Professions, Trades, Callings and Employments Taxation (Haryana Amendment) Act, 1965.
- 2. Amendment of section 7 of Punjab Act 7 of 1956. In section 7 of the Punjab Professions, Trades, Callings and Employments Taxation Act, 1956, as in force in the Union term tory of Chandigarh, after sub-section (2), the following Explanation shall be added, namely:

"Explanation. For the purposes of this section, the expression local authority shall include the Life Insurance Corporation of India, the State Bank of India, any University or such other institution or company or class of institutions or companies as the State Government may be notification in this behalf, direct.".
