Sir/Madam,

Your attention is invited to this Ministry's Advisory dated the 7th March 2017 on the subject mentioned above, a copy of which is attached for the convenience of reference. The Unique Identification Authority of India (UIDAI), as part of its endeavour to make available the Aadhaar facility to all eligible residents, has proposed to conduct Aadhaar enrolment/updation camps in all Jails of the country for prison inmates.

2. Since Aadhaar enrolment is done on the basis of valid supporting documents, **as a special measure for prison inmates**, UIDAI has agreed to accept the 'Prisoner Induction Document (PID)' as a valid document for such enrolments. The PID can be generated from the ePrison module (sample copy attached) and when authenticated by the authorised Prison Officer with his signatures and seal, it will be accepted by the UIDAI as a valid document for enrolment/update of Aadhaar.

3. You are requested to make use of this special dispensation made available by the UIDAI and facilitate enrolment/updation of Aadhaar for prison inmates. As part of this initiative, the Head of Prisons Department of the State/UT may chalk out a plan for conducting enrolment/update camps in all prisons of the State/UT and coordinate with the local UIDAI regional office in this regard, who will facilitate in organizing such camps in the jail premises. A copy of the SOP finalised by UIDAI is attached for reference.

Subject: Aadhaar Seeding of Prisoners.

Sir/Madam,

Your attention is invited to MHA's Advisory No. V-17013/09/2014-PR dated 27.9.2014 regarding Access of Prisoners to Aadhaar and No. V-17013/2/2017-PR dated 17.2.2017 regarding use of Aadhaar for verification of identity of persons visiting Prisons. Prison administration is an important element of the criminal justice system in India. The objective of prison and correctional administration is to protect the society against crime by secure and safe custody of prisoners and to develop a sense of discipline amongst them. Although Prisons is a State subject, however, considering the importance of efficient prison administration in the safety, security and wellbeing of prisoners, the Government of India has been providing continuous guidance and support to the States in strengthening the safety and security arrangement in prisons.

2. You are aware that Aadhaar is now widely used in various Government Departments for attendance as well as a unique identifier for DBT under various centrally sponsored schemes. Section 57 of The Aadhaar (Targeted Delivery Of Financial and other Subsidies, Benefits and Services) Act, 2016 allows the use of Aadhaar Number for establishing the identity of an individual for any purpose, whether by the State or any Body or corporate or person, pursuant to any law, for the time being in force, or any contract to this effect, provided that the use of Aadhaar Number is subject to the procedure and obligations under section 8 and Chapter VI of the said Act.

3. Considering the fact that 109 crore Aadhaar numbers have been issued, which covers almost 99% of adult population, it has been felt that prison inmates should also be Aadhaar seeded and various aspects of day to day prison administration like production before court, return to prison, transport, health facilities, transport to outside hospital, interview, free legal aid, parole, temporary release mechanism, education/vocational training, release from prison etc. be regulated by use of Aadhaar. It will be of immense utility to link the inmates of correctional homes to Aadhaar as this will not only help in efficient handling of prisoners but will also ensure that the facility does not get misused and that the security of the prisons is not compromised.

4. It is expected that all States/UTs will give due attention and priority to this communication and shall take appropriate steps for Aadhaar seeding of all aspects of prison administration and integrate Aadhaar in the e-prison system also.

5. Action taken in the matter may please be intimated to the Ministry of Home Affairs.

Sub: Standard Operating Procedure (SOP) to be followed for camp enrolment at Jails - reg.

The overall Aadhaar saturation level in the country has now crossed 93% and in case of adult population the saturation level is nearly 100%. part of our endeavor to enroll all eligible residents for Aadhaar, it has been decided to conduct regular Aadhaar enrolment camps at the Jails in co-ordination with State Governments to provide Aadhaar enrolment/update services to the prisoners.

2. As per the Prison Statistics India 2021' published by NCRB (MHA), there are 1319 prisons in the country (564 Sub Jails, 424 District Jails, 148 Central Jails, 88 Open Jails, 41 Special Jails, 32 Women Jails, 19 Borstal Schools and 3 other than the above Jails) having an inmate population of nearly 5.5 lakh as on 31st December 2021.

3. The following Standard Operating Procedure is to be followed for conducting enrolment camps at Jails:

- The State Government (Head of the Prisons Department of the State/UT) to chalk out a plan for conducting enrolment camps at all the prisons in the State at least once in a year. The Jail-wise tentative dates should be finalized in consultation with the Jail authorities and concerned UIDAI Regional Office.
- 2. The Head of Prisons Department of the State/UT to formally communicate the tentative calendar to all the Jails in the State/UT and concerned UIDAI Regional Office for further necessary action.
- 3. The Jail authorities to fix the date and plan for conducting enrolment camp at the concerned prison as per the tentative calendar in consultation with concerned UIDAI Regional Office.
- 4. Regional Office to arrange enrolment camps through Registrar available in the area (preferably UIDAI ASK or State Registrar).
- 5. The required logistics including arrangements at Jail for conducting the enrolment camp to be arranged by the concerned Jail authorities.
- 6. The enrolment of prisoners to be conducted based on the valid supporting documents as published by UIDAI from time to time. The Prisoner Induction (PID) document issued by the Department of Prisons (sample copy attached) and duly certified with seal and signature of the authorized Jail authority may also be accepted as valid document for such enrolments subject to the following conditions:

- a) In case of document having multiple or alias names, the first name in the document shall be recorded as name of the resident.
- b) Date of Birth/age of the resident shall be recorded as declared/approximate as per the provisions available in The Aadhaar (Enrolment and Update) Regulations 2016.
- c) No relationship details or c/o field shall be captured as part of the address field.
- d) In case the present address and permanent address are available in the document, permanent address shall be captured as address of the resident.
- 7. UIDAI Regional Offices to maintain record of such enrolments and to be included in the monthly reports.
- 8. After completion of the process, the Aadhaar letter shall be delivered to the residents at their Jail address.
- 4. This issues with the approval of Competent Authority.
