


All the concerned sections will:

- (iii) Divisional heads may ensure that the Hindi version of the answer is prepared and placed in file before placing the file to Hon/ble MOS/ HM.
- (iv) Provide 10 copies of the approved reply of the respective answer of Starred Questions, along with 'Note for Supplementary' to the Parliament Section on Friday i.e. 5th March, 2021 by 10.00 A.M. before the briefing meeting for Lok Sabha starred questions, for preparation of Parliament Pads for the use of the Ministers and the Senior officers. In this regard, instruction issued by HMO on 19.01.2021 may be followed scrupulously.
- (v) All the Divisional Heads are requested to direct the concerned Dir/DS/US to authenticate the final/fair typed copy by R&I with the approved draft in R&I Section on Monday 8th March, 2021 by appending his/her signature on the reverse of each page of the final version before it goes for printing by R&I Section.
