- (viii) The bids addressed to Under Secretary (Ad-III), Hall No. 2, North Block, New Delhi, should be submitted by the last date and time of submission of the tender online at e-mail: subodh79@nic.in/birender.singh64@nic.in. However, the financial aspects may be submitted in sealed envelope for the sake of secrecy/fair competition.
- (ix) The PSUs/firm should mention the item wise rates & agency charges separately. Rates are required to be mentioned unit wise in respect of all items.
- (x) The Department reserves the right to reject the quotation in whole or in part without assigning any reason thereof.
- Preference to Make In India products (For bids < 200 Crore):Preference shall (xi) be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate.
