No. U-13019/1/2015-ANL—In supersession of all earlier notifications on the subject, the President is pleased to re-constitute the Advisory Committee associated with the Minister of Home Affairs for the Union Territory of Lakshadweep.

2. The Advisory Committee shall consist of the following Members :—

- (a) Administrator, Lakshadweep
- (b) Member of Parliament, Lok Sabha representing the Union Territory.
- (c) Representatives from District Panchayat, Lakshadweep.
 - (i) President, District Panchayat.
 - (ii) Leader of opposition.
- (d) Nominated Members of Standing Repute, representing civil society etc.
 - (i) Smt. M. C. Fameena, Pappadam House, Kavaratti Island, Lakshadweep-682555
 - (ii) Shri K. P. Muthukoya, Firdouse, Opposite Post Office, Kavaratti. Lakshadweep-682555
 - (iii) Shri P. Jafar Shah, Kotham, Kavaratti, Lakshadweep-682555
 - (iv) Dr. M. Koyamma Koya, Maplat, Androth Island, PO, Kavaratti, Lakshadweep-682551
 - (v) Shri M. P. Sayed Mohammed Koya, Asna House, MG Road, Kavaratti. Lakshadweep-682555
- (e) Joint Secretary (UT) as Member Secretary.

3. The Advisory Committee shall be consulted in regard to following matters :—

- (a) General questions of policy relating to the administration of the territory in the State field.
- (b) All legislative proposals concerning the territory in regard to matters in the State list.
- (c) Such matters relating to the annual financial statement of the Union in so far as it concerns the territory and such other financial questions as be referred to it by the President.
- (d) All developmental issues concerning the Union Territory.
- (e) Internal security related issues.
- (f) Any other matter on which it may be considered necessary or desirable by the Minister of Home Affairs that the Advisory Committee should be consulted.

4. The terms of nominated members would be for a period of two years. The Committee shall meet once in a year or as per convenience of the Chair/HM. The office of the member of the Advisory Committee shall be honorary and shall not carry any salary or remuneration.
