

Ministry of Home Affairs-Major Achievements, significant Development and important events for the month of September, 2020.

Hon'ble Home Minister took a meeting with Chief Minister Tripura on 21.09.2020 to review the pending issues of Tripura relating to Bru Agreement signed on 16.01.2020 and MoS signed with NLFT/SD on 10.08.2019.

2. On 20.09.2020 Union Home Minister took a meeting with Chief Minister of Assam to discuss various issues of Assam including implementation of Bodo Accord within timeline.

3. Union Home Secretary have chaired a meeting on 08.09.2020 with the representatives of cinemas/ multiplex Industry associations to hear their view on the issue of re-opening of the industry and other ancillary matters.

4. Union Home Secretary have also taken a meeting on 08.09.2020 regarding turnover of Medical and Para-Medical staff at Sardar Vallabh Bhai Patel COVID-19 Hospital, New Delhi.

5. Union Home Secretary have taken a meeting to review of management of COVID-19 situation in National Capital Region (NCR) on 23.09.2020.

6. For management of Covid-19 the Empowered Groups under the Disaster Management Act, 2005 have been re-constituted on 11.09.2020.

7. A D.O. letter was issued on 18-09-2020 to all Chief Secretaries and Administrators of States/UTs regarding un-interrupted supply of Medical Oxygen in the country.

8. On 30.09.2020, MHA issued guidelines for phased re-opening and extended the lockdown in Containment Zones upto 31.10.2020. D.O. letter issued to all Chief Secretaries and Administrators of States/UTs to ensure compliance of guidelines for phased re-opening.

9. Ban on National Socialist Council of Nagaland (Khaplang) as "Unlawful Associations" under Unlawful Activities (Prevention) Act, 1967 has been extended for five more years upto 27.09.2025 vide MHA Notification No. SO 3350 (E) dated 28.09.2020.

10. Suspension of Operation (So0) agreements with KNO (Kuki National Organization) and UPF (United Progressive Front) of Manipur have been extended for six more months till 28.02.2021.

11. Proposal for construction of 32 ICBR-II roads measuring 638.12 Km amounting to Rs.12434.90 crore has been approved on 21.09.2020

13. The Advisory(SoP) on police service K9s(PSKs) has been issued on 16.09.2020 to ascertain the technical proficiency of PSKs in detection of explosives and narcotics substances by conducting K9 Proficiency Evaluation Test (K9PET) among CAPFs and other Central or State Police and Law Enforcement agencies. The advisory is aimed to ensure technical proficiency detection of DoGs by each organization internally every six months and annually by independent or third party assessments for their certification in assigned task.

14. AS (PM) review procurement plans of BSF and CRPF on 10.09.2020 respectively.

15. On 28.09.2020, a meeting was conducted with all CAPFs to review progress of creation of 100 new categories on GEM portal.

16. Sanctions for prosecution for filing the charge sheet against 35 accused persons were accorded in accordance with section 45(1) of the Unlawful Activities (Prevention) Act, 1967 and section 196 of CRPC.

17. The Rashtriya Raksha University Bill, 2020 was passed by both houses of Parliament. The RRU Act,2020 has been notified on 28.09.2020. It became effective from 1st October, 2020.

18. The newly constituted Standing Committee for Police Research (SCPR) held its first meeting in September, 2020. The SCPR finalized two projects for award of grant by BPR&D. These projects are : 'Functioning and impact of open prisons on rehabilitation of prisoners of radicalization in India' and 'An exploratory study on Prevention and Remedies'.

19. During the month, the Hon'ble president assented 'The Contract Labour (Regulation and Abolition) (Goa Amendment) Bill, 2020'; 'The Industrial Disputes (Goa Amendment) Bill, 2020' ; and 'The Factories Disputes (Goa Amendment) Bill, 2020'.

20. Previous sanctions of the Hon'ble President have been conveyed to State Govts. on 'Madhya Pradesh Sahukar (Sanshodhan) Vidheyak, 2020' and 'Madhya Pradesh Anusuchit Janjati Rin Vimukti Vidheyak, 2020'.

21. Instructions of the Hon'ble President for promulgation of 'The Contract Labour Regulation and Abolition) (Odisha Amendment) Ordinance' and 'The Factories (Odisha Amendment) Ordinance, 2020' have been conveyed to the State Govt. on 17-09-2020.
