WHEREAS the Central Government in exercise of the powers conferred by Sub-section (1) of Section 3 of the Unlawful Activities [Prevention] Act, 1967 (37 of 1967) (hereinafter referred to as "the Act") has declared the Islamic Research Foundation to be an unlawful association with immediate effect vide Notification No. S.O. 4731(E) dated 15.11.2021 [published in the Gazette of India Extraordinary, Part-II, Section 3, Sub-section (ii) dated 15<sup>th</sup> November, 2021..


AND WHEREAS vide Gazette Notification No. S.O. 5180 (E) dated 13<sup>th</sup> December, 2021, in exercise of powers under Section 5(1) of the Act, the Central Government has constituted the Unlawful Activities (Prevention) Tribunal comprising Hon'ble Mr. Justice D.N. Patel, Chief Justice of Delhi High Court, for the purpose of adjudicating whether or not there is sufficient cause for declaring the said Islamic Research Foundation (IRF) as an Unlawful Association as required by Sub-section (1) of Section 4 of the Act.

Now THEREFORE, a Notice is hereby given under sub-section (2) of Section 4 of the Act read with Rule 6 of the Unlawful Activities (Prevention) Rules, 1968 and you are hereby called upon to show cause in writing within 30 days from the date of service of this Notice as to why Islamic Research Foundation (IRF) be not adjudicated for declaring as an unlawful association and why an order should not be made confirming the declaration to the above effect made in the above mentioned Notification.

The objections/reply/written statement, if any, may be filed/delivered within the statutory period of 30 days from the date of service before the Registrar of this Tribunal i.e. the undersigned at Room No. 220, IInd Floor, A Block, High Court of Delhi, Sher Shah Road, New Delhi-110003. In case objections/reply/written statements are in regional or vernacular language, true English Translation thereof should be also attached.

You may cause an appearance on your behalf before the Tribunal on 28<sup>th</sup> January, 2022 at 2.15 p.m. in the Court Room No. 1, Delhi High Court, Sher Shah Road, New Delhi-110003, either through a duly authorized representative or an instructed Counsel/Advocate, where after irrespective of your appearance, the Tribunal shall proceed as per sub-Section (3) of Section 4 of the Act.
