No. F.16/4/2013/HP-I/Estt./5234 to 5237.—In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs Notification No. F. 24/78/68-DS(S), dated 24th September, 1968, the Lieutenant Governor of the National Capital Territory of Delhi, after prior consultation with the Union Public Service Commission, New Delhi is pleased to make the following rules further to amend the Delhi Police (Appointment and Recruitment) Rules, 1981, relating to the post of Legal Advisor in Delhi Police, namely:—

- 1. Short title and commencement.— (1) These Rules may be called the Delhi Police (Appointment and Recruitment) (Amendment) Rules, 2014.
 - (2) They shall come into force on the date of their publication in the Delhi Gaze
- 2. Amendment of rule.—

In the schedule to the Delhi Police (Appointment and Recruitment) Rules, 1981

- (a) In column 2, for the existing entry, the following entry shall be substituted, namely:—
 - 01 *(2014) Subject to variation dependent on workload.
- (b) In column 4, for the heading and the entries relating thereto, the following entry shall be substituted, namely:—

"Pay Band and Grade Pay / Pay Scale

PB-3, Rs.15600-39100 (Grade Pay Rs. 5400)"

(c) In column 6, for the existing entry, the following entry shall be substituted, namely:—

Not exceeding 35 years (Relaxable for Govt. servants up to 5 years in accordance with the instructions or orders issued by the Central Government)

Note: The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti Districts and Pangi Sub-Division of Chamba District of Himachal Pradesh, Andaman and Nicobar Island or Lakshadweep).

(d) In column 7, for the existing entry, the following entry shall be substituted, namely:---

Essential:

- (i) Degree in Law of a recognized University.
- (ii) 5 years experience at Bar or in any Legal Department.

Note 1: Qualifications are relaxable at the discretion of the UPSC in case of candidates otherwise well qualified.

Note 2: The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC in the case of candidates belonging to SC/ST, if, at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for

- (e) In column 10, for the existing entry, the following entry shall be substituted, namely:--By promotion failing which by deputation (including short term contract) failing bothby direct recruitment
- (f) In column 11, for the existing entry, the following entry shall be substituted, namely:-In case of promotion: Assistant Legal Advisor with three years regular service in the grade in scale of Rs.9300-34800 plus Grade Pay- Rs.4600 in PB-2.

Note: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying/ eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/eligibility service.

In case of deputation (including short term contract)

Officers under the Central / State Governments / Union Territories / Semi-Government, Autonomousor Statutory Organizations:

1. (i) holding analogous posts;

(ii) with two years regular service in the scale of pay of Rs.9300-34800 plus Grade Pay Rs. 4800 in PB-2 or equivalent;

- (iii) with three years regular service in the scale of PB-2 Rs. 9300-34800 plus Grade Pay-Rs. 4600 or equivalent; and
- 2. Passessing the educational qualifications and experience laid down for direct recruits under column 7.

Note: (Departmental Officers in the Feeder-Category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by

(Period of deputation including period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other Organization/Department of the Central Government shall ordinarily not exceed three years).

The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of application.

(g) In column 12, for existing entry, the following entry shall be substituted, namely:—
