OFFICE MEMORANDUM

Subject:- Extension of Dynamic Assured Career Progression (DACP) Scheme to Veterinary Officers of CAPFs & AR-reg.

The undersigned is directed to refer to this Ministry's UO No.II-27012/39/2015-PF.I dated 14.05.2018 vide which approval of the Competent Authority has been conveyed to SSB for implementation of Hon'ble High Court of Delhi order dated 30.01.2015 in W.P(C) No.3397/2013 filed by Dr.Ranvir Singh Gahlawat & Ors Vs. UOI & Anr., as proposed by SSB.

2. The matter regarding framing modalities for extending the benefits of DACP Scheme to Veterinary Officers of CAPFs has been examined in the light of SSB's UO No.14/SSB/A-4/89(79)-I/97 dated 27.06.2018, suggestions given by ADG(Medical), CAPFs, NSG & AR and in consultation with Ministry of Health & Family Welfare(MoH&FW), IFD(MHA), Department of Expenditure (Ministry of Finance) and Ministry of Law & Justice. It has been decided to extend the benefits of DACP Scheme to Veterinary Officers of CAPFs & AR as per the following formulation, with effect from 05.04.2002 i.e. the date from which MoH&FW has implemented the CAT, PB, New Delhi order dated 24.09.2010 in O.A.1870/2009 in the matter of Dr.Parvesh Nath Mehra Vs UoI & Others:-


