iii)	The maximum permissible tenure for attachment of Para Military personnel drawn from various Para Military Forces in Ministry of Home Affairs.	Attachment period of CAPFs personnel with MHA is 3 years. However, the period is extended based on the exigencies/requirement of service of concerned personnel.
iv)	The frequency (i.e. quarterly/half yearly or annually) for review of cases by Ministry Home Affairs for repatriation and the crucial date for deciding the completion of attachment tenure of Para Military personnel as per policy, if any.	The attachment period of each CAPFs personnel is being reviewed on completion of 3 years tenure period and no specific period/date has been prescribed.

v)	Names of Para Military personnel attached to Ministry of Home Affairs from different forces during the last five years.	
vi)	Name of Para Military personnel repatriated to their concerned forces during the last five years.	This information is not available in Police-II Division, MHA and may be available with CAPFs. RTI application is therefore, being transferred to CPIOs
vii)	A list of CAPF personnel presently working on attachment basis in Ministry of Home Affairs, their date of appointment in MHA and date of completion of their stipulated tenure as per the policy of MHA.	BSF, SSB, CRPF, ITBP, CISF and Assam Rifles under the provisions of Section 6(3) of RTI Act, 2005 for appropriate action.
viii)	Copies of requests received from Para Military Forces for repatriation of their respective personnel on completion of their attachment period.	The information may be available with the CAPFs.


