Dr Siddhartha Mukherjee

Dr. Siddhartha Mukherjee is an Indian-born American physician, scientist and writer. He is best known for the 2010 book, The Emperor of All Maladies: A Biography of Cancer which won the Pulitzer Prize and an award from The Guardian. It was named one of the 100 most influential books written in English since 1923 by TIME and one of the 100 best works of non-fiction by The New York Times Magazine. Currently he is an Assistant Professor of medicine at Columbia University and Staff Physician at Columbia University Medical Center in New York City.

- 2. Born on July 21, 1970 in New Delhi, Dr Mukherjee attended St. Columba's School in Delhi and as a biology major at Stanford University, he worked in Nobel Laureate Paul Berg's laboratory defining cellular genes that change the behaviors of cancer cells. He then won a Rhodes Scholarship to Oxford University, where he earned a D.Phil. in immunology from Magdalen College, Oxford. After graduation, he attended Harvard Medical School (HST) where he earned an M.D. His postgraduate years consisted of a residency in internal medicine followed by an oncology fellowship at Massachusetts General Hospital.
- 3. As a hematologist and oncologist specializing in the treatment of leukemia and pre-leukemic diseases, Dr. Mukherjee is known for his work on the formation of blood and the interactions between the micro-environment (or "niche") and cancer cells. He is also known for promulgating the theory of cancer as an "organismal" disease i.e. a disease best studied at a whole organism level, with particular attention to its cellular context. His work has been published or featured in major scientific journals, including Nature and The New England Journal of Medicine and major magazines such as the New York Times, the New Yorker and Granta. His scientific work addresses the links between normal stem cells and cancer cells. His lab, based at Columbia University's Herbert Irving Comprehensive Cancer Center, has performed investigations on the microenvironment of stem cells, focusing particularly on bloodforming stem cells. The lab has also identified novel genetic mutations in myelodysplasia and acute myelogenous leukemia and has played a leading role in finding therapies for these diseases in the clinical setting His work has been recognized through many NIH and private foundation grants, including the prestigious NIH "Challenge Grant" awarded to pioneering researchers in 2009.
- 4. Dr Mukherjee has published widely in scientific journals, including papers in Nature, Neuron, the Journal of Clinical Investigation, The New England Journal of Medicine and others. In 2010, Simon & Schuster published his book, The Emperor of All Maladies: A Biography of Cancer, detailing the evolution of diagnosis and treatment of human cancers from ancient Egy₁ to the latest developments in chemotherapy and targeted therapy. The Oprah magazine listed it in its "Top 10 Books of 2010". It was also listed in "The 10 Best Books of 2010" by The New York Times and the Top 10 Nonfiction Books' by Time. It won the Pulitzer Prize.
- 5. Dr Mukheriee has been honoured with many awards such as Rhodes Scholarship (1993-1996), Gabrielle Angel's Leukemia Foundation Award in 2010, Pulitzer Prize for The Emperor of All Maladies in 2011, PEN/E. O. Wilson Literary Science Writing Award for The Emperor of All Maladies in 2011, Cancer Leadership Award (shared with Kathleen Sebelius and Orrin Hatch) in 2011, TIME magazine included The Emperor of All Maladies as 100 Best Non-Fiction books of all TIME in 2011. Time included him as the 100 most influential people in 2011, Guardian Prize for The Emperor of All Maladies in 2011, Boston Public Library Literary Lights in 2012 and Memorial Sloan Kettering Medal for Outstanding Contributions to the Biomedical Sciences in 2013.
