ITF warns anew or cruise jobs scam



Further warnings to seafarers who respond to advertisements offering jobs on cruises ships have been issued by the International Transport Workers' Federation (ITF), the

Faiplay Daily News reported.

The latest advertisement appeared in a Uruguayan newspaper stating that jobs were available at a website named www.jobsoncruises.com.

A Uruguayan told the ITF that he and his brother responded to the advertisement and received a letter from a company called Sea Cruises Enterprises.

The man revealed to the TTF that the letter was sent from Malmö, Sweden and was signed 'M Arnoldus,' and in it he was told to send \$196 as an evaluation fee to an address in Canada called "Sea Cruise Enterprise, a.v.v. Evaluation Processing Center, 1930 Yonge Street, Suite 1020, Toronto, ON, Canada M4S 1Z4."

In response, ITF spokesman Sam Dawson confirmed that Sea Cruise Enterprises is a criminal operation.

"The Canadian address is a post office box only and the jobs don't exist," he warned.
