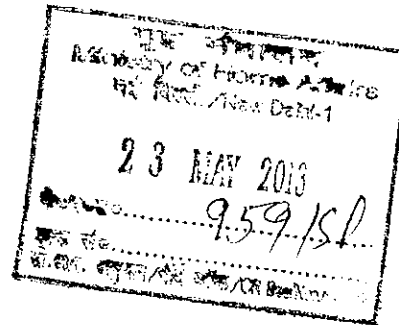

My name is Poorna Nand and I am an Indian citizen. My wife's name is Nienke Gijswijt and she is a Dutch citizen. We have a daughter and her name is Dina Ilahi Gijswijt. She is also a Dutch citizen. They both have PIO cards.

Now recently they got new passports. I want to know about the endorsement of passports on PIO cards and registration. (Copies of PIO cards, Passports and Residential Permits are enclosed)

1-The PIO card says that in case of new Passport, Endorsement should be made by a competent officer. So the question is who will do the endorsement? Can FRO/SP Pauri do the endorsement or we have to come to Delhi(FRRO) for that?

2-The PIO card says that if the PIO card holder is staying in India for more than 180 days then she should be registered at FRO. Now as they are already registered at FRO Pauri, because they were on Residential Permit before they got PIO, so do they again have to register at FRO Pauri or the former registration is enough?(Though we have sent the copies of PIO cards to the FRO Pauri).

I hope to get the reply as soon as possible.

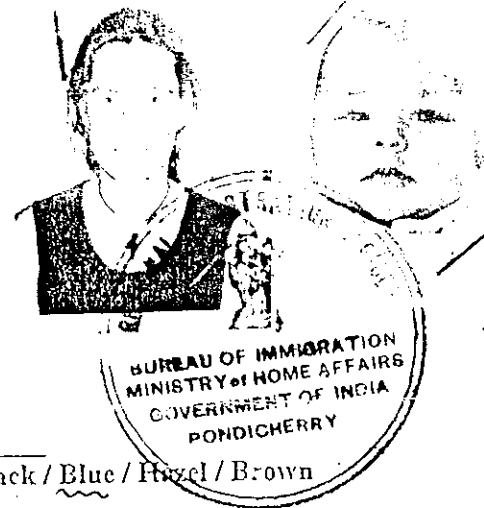

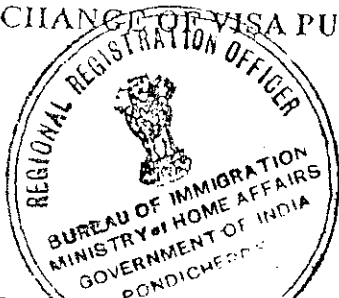
RULES

This Permit must be surrendered at the time of final departure from India to the Registration Officer of place from which he/she leaves India.

In the event of he/she not departing from India before he/she will, unless he/she obtain the permission of the Central Government to remain for a longer period, be liable to prosecution for contravention of the provisions of Foreigners Act, 1946 punishable with imprisonment for a period of five years and with fine and will also be liable to expulsion from India.

Application for an extension of the period of this permit must be made at least sixty days before expiry and must be addressed to the Government of India through the State Govt. The Government has discretion to reject any application, which does not disclose adequate grounds for extension.

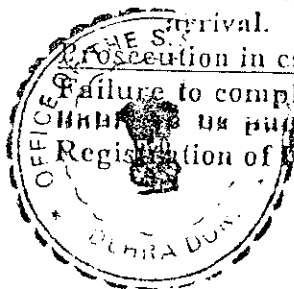
NOTICE

Every registered foreigner is required :-

- (i) On the demand of any Registration Officer or Magistrate or any Police Officer not below the rank of Head Constable to produce this Certificate and his passport or such other proof of identity as may be required of him by such Magistrate or Officer.
- (ii) To surrender his certificate of registration, if he is about to depart finally from India either to the Registration officer of the place where he is registered or of the place from where he intends to depart or to the immigration officer at the port/check post of exit from India.
- (iii) To intimate in person or through an authorized representative or by post under certificate of posting the Registration Officer of the district of Which has registered address situated.
 - a) Before he leaves his registered address, if he proposes to be absent from his registered address for a continuous period of eight weeks or more, the address of addresses at which he, proposes to stay and the date on which he expects to return to his registered address.
 - b) If he proposes to change his registered address or to leave India, the particulars of his new address and the date of the proposed change of departure; and
 - c) Any circumstances, which in any way affect the accuracy of any of the particulars, set out in his certificate of Registration.
- (iv) If he stays for more than eight weeks at any place (other than a hotel or premises where travelers are accommodated) in any district other than the district in which his registered address is situated to report his presence in that other district to the Registration Officer thereof within seven days of his arrival.

Prosecution in case of Failure to comply with rules:-

Failure to comply with the foregoing provisions render the holder of this certificate liable to be punished with imprisonment or fine or both, under section 3 of the Registration of Foreigners Act, 1939 (XVI of 1939)



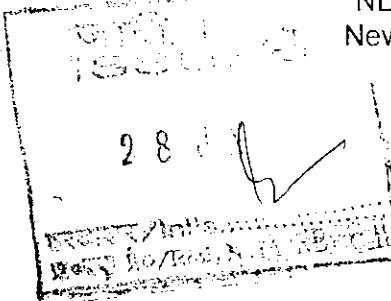

Sir,

Please refer to your application dated 20.05.2013 (received by the then CPIO on 29.05.2013 on transfer from Shri S. Samanta, Under Secretary(RTI), Ministry of Home Affairs, vide their O.M. No.A-43020/01/2013/-RTI dated 28.05.2013) seeking information under the RTI Act, 2005.

2. With regard to information sought by you in point no 1 & 2 of your RTI application, it may be stated that the endorsement of new passport on PIO card can be made by the authority who has originally issued the PIO card. In the event of continuous stay in India exceeding 180 days, the PIO card holder must get himself/herself registered, within 30 days of the expiry of 180 days, with the concerned jurisdictional FRRO/FRO. This registration by the PIO card holder would be required even if the person had earlier registered on a valid visa and obtained Residential Permit. However, children below the age of 16 years are exempt from the requirement of registration.

3. If you are not satisfied with the information furnished, you may file an appeal to Shri V.Vumlunmang, Joint Secretary (Foreigners) & Appellate Authority, Ministry of Home Affairs, Foreigners Division, NDCC-II Building, Jai Singh Road, New Delhi within the prescribed time limit.
