

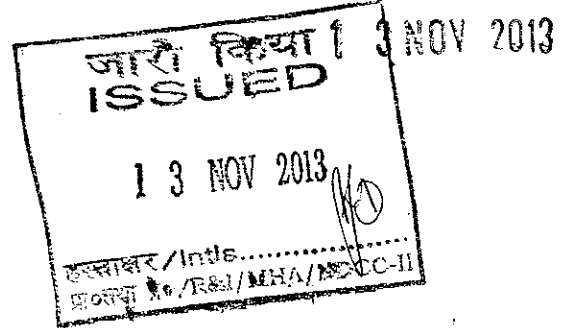

Subject:- First Appeal under the RTI Act-2005-reg.

Sir,

Please refer to your First Appeal (online) Registration No. MHOME/R/2013/60038 dated 15.08.2013.

2. The grounds cited in your appeal have been examined. It is observed that the following issues have been raised in your appeal:

- (i) Original RTI request has been modified without citing any reason. Reasons for providing Z+ security to individuals in each case have been removed from the latest status.
- (ii) No reply has been sent with reference to your RTI application.

3. As regard issues raised in Para 2(i) above, it may be pointed out that a reply with reference to your RTI application was sent by CPIO vide letter of even number dated 25.09.2013 (copy enclosed) wherein it was clearly stated that the security to an individual is provided on the basis of threat assessment carried out by the security agencies. Thus the basis for providing security (including Z+ category) was clearly explained to you. It was also indicated that further details are exempt in terms of Section 8(1)(g) and 24(1) of the RTI Act-2005 as the security agencies are exempt from the provisions of RTI Act-2005 and therefore, the inputs from such agencies cannot be disclosed under the provisions of the RTI Act.

4. As regards the other issues of non-receipt of information raised by you, as indicated above, the requisite information was provided to you vide this Ministry's letter of even number dated 25.09.2013.
