- 2. Ministry of Petroleum & Natural Gas vide its OM No.13020(19)/64/2018-LPG-PNG dated 02/04/2018 (copy enclosed) has informed that 8% reservation is provided under sub-category of Government personnel category (GP). The eligible applicant to apply under the sub-category includes, among others, includes personnel of Central Para Military Forces/ Special Forces disabled while performing official duty are widows/dependent(s) of Central Para Military Forces /Special Forces personnel who died while official duty (only one of either widow(s)/dependent(s) of the eligible deceased CAPFs/Special Forces personnel can claim reservation, as applicable).
