- 2- Where has he been posted in his job, kindly provide information right from his entry in his job.
- 3- How many times Mr. Hans Raj Singh has been transferred in his job.
- 4- What was the annual income of Mr. Hans Raj Singh in the period 2003-4 to 2013-14.
- 5- Whether Mr. Hans Raj Singh has submitted declaration of his & his family's assets & property then what is his disclosed movable and immovable assets and property according to the last submitted declaration, kindly provide certified copy.
- 6- Whether any FIR was registered against him, if yes then kindly provide the FIR number and status of the case.
- 7- It has been informed anonymously that in the year 1996, Mr. Hans Raj Singh (when he was LDC). He was caught by C.B.I. taking bribe; consequently he was in 14 days custody and was in Tihar jail. Whether this information is correct? If yes, then kindly provide case details.
- 8- Kindly provide information that how many total cases have been lodged against Mr. Hans Raj Singh, as per official record. Kindly provide case certified copy of all those cases.
- 9- In respect of point 8, kindly provide information that how many times Mr. Hans Raj Singh has been arrested & for how many days he was under custody after each arrest.
- 10- Whether Mr. Hans Raj Singh has been alleged for any crime against women? If yes and details of that case has not been provided in the answer of point 8, then kindly provide certified copy of that case.
