Sir / Madam,

The Ministry of Home Affairs requires the services of suitable officers for filling up of two (02) posts of Associate Professor in National Fire Service College, Nagpur under the Ministry of Home Affairs on deputation (Including short-term contract) basis.

2. The posts of Associate Professor are General Central Service, Group A, Gazetted, Non-Ministerial at Pay Band-4 (Rs. 37400-67000/-) with Academic Grade Pay of Rs. 9000. Pay of the officers selected would be fixed as per the existing instructions of the Government of India.

3. The eligibility criteria for deputation (including Short-Term Contract) for the post of Associate Professor are to be governed in accordance with the University Grants Commission norms as on date. The grades from which deputation to the post of Associate Professor is to be made is as under:-

(a) Officers under the Central Government or State Government or Union territories or Public Sector Undertakings or recognised research institution or Universities or semi-Government or Statutory or autonomous organisations:

(i) holding analogous post on regular basis in the parent cadre or department;

or

(ii) Assistant Professor in the discipline of Fire or Civil or Electrical or Mechanical, completing three years of regular service in the Academic Grade Pay of Rs. 8000 in the parent cadre or department;

and

(b) Possessing the following educational qualification and experience

Essential:

- (i) Ph.D. Degree with First Class Bachelor's or Master's Degree in Fire or Civil or Electrical or Mechanical branch of Engineering and Technology;

and

- (ii) experience of eight years in teaching, research or industry at the level of Lecturer or equivalent grade, excluding period spent on obtaining the research degree.

Desirable:

- (i) Teaching, research, industrial or professional experience in a reputed organization;
(ii) Published work, such as research papers, patents filed or obtained, books or technical reports;
(iii) Experience of guiding the project work or dissertation of Post Graduate or Research Students or supervising Research and Development projects in industry.

Note 1.- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for appointment by promotion.

Note 2.- Period of deputation [including short term contract (ISTC)] including period of deputation (ISTC) spent in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation (ISTC) shall be 'not exceeding fifty-six years' as on the closing date of receipt of applications.

4. Officers who volunteer and are sponsored by their Ministry/Department/State Governments/UTs Administration etc. for the post will not be permitted to withdraw their names later.

5.
